## FIRST AID MEASURES

### FIRST AID TREATMENT

**Swallowed:** If swallowed, **DO NOT** induce vomiting. Give a glass of water to drink and seek medical advice.

**Eye:** If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor urgently.

**Skin:** If skin contact occurs, remove contaminated clothing and wash skin thoroughly. Wash clothing before reuse.

**Inhaled:** Remove victim from exposure if safe to do so. Remove contaminated clothing and loosen remaining clothing.

Allow patient to assume a comfortable position and keep warm. Seek medical assistance if symptoms persist.

**First Aid facilities:** Potable water should be available to rinse eyes or skin. Provide eye baths and safety showers.

## FIRE FIGHTING MEASURES

**Fire/Explosion Hazard:** This product is not combustible. Exposure to high heat sources may cause decomposition of the product and the production of toxic fumes. Fire fighters to wear self-contained breathing apparatus in the event of a fire. Use water fog, or fine spray mist to extinguish.

## ACCIDENTAL RELEASE MEASURES

**Spills and Disposal:** Spills may be slippery. Remove non-essential personnel from the area. Ensure that any acids or other products of incompatible classes near the spill are removed. Dam and recover. Prevent entry into drainage systems, sewers and waterways. Collect with inert absorbent material such as sand or earth. Consult Local Authority on disposal.

### HANDLING AND STORAGE

---

**Precautions for Safe Handling and Storage:** Classified Dangerous Goods for storage. When not being used, the product containers should be stored upright, and secured with the original closure. Store in a cool area away from direct sunlight to reduce chemical breakdown. If transfer to another container becomes necessary, ensure that the container is clearly labelled, the container is of a type suitable for the product, and is clean and free of other materials. Do not eat, drink or smoke in contaminated areas. Before eating, drinking or smoking, remove contaminated clothing and wash hands.

**Dispensing:** Always use clean and dry equipment to dispense the product. Dispenser should be cleaned before and after use. All dispensers should be washed out after use.

**Flammability:** Non-combustible material.

### EXPOSURE CONTROLS / PERSONAL PROTECTION

---

**Exposure Standards:** There are no exposure standards available for this product. The ASCC has set an exposure standard of 2 mg/m<sup>3</sup> for Potassium Hydroxide. ASCC have also set an exposure standard of 3 mg/m<sup>3</sup> for Chlorine, which is a decomposition product of this material.

**Personal Protective Equipment:** Use sensible work practices that reduce operator exposure to the product. Protective clothing and equipment must be worn: chemically impervious gloves, safety glasses, overalls, waterproof apron and rubber boots. Respiratory protection should be used if there is a risk of exposure to high vapour concentrations. Respirators should comply with AS1716 or an equivalent approved by a state/territory authority.

**Engineering Controls:** Ensure that adequate ventilation is provided. Maintain air concentrations below recommended exposure standards. Avoid generating and inhaling mists. Keep containers closed when not in use.

### STABILITY AND REACTIVITY

---

**Reactivity Hazards:** Do not store near high heat sources or acids. Reacts vigorously with acids producing dangerous gaseous chlorine. Reacts with metal salts, peroxides and reducing agents. Reacts with soft metals such as copper, aluminium, zinc, galvanising.

#### HEALTH EFFECTS

*Acute:*

**Swallowed:** Corrosive. Will cause severe irritation and possible chemical burns to the mouth and digestive tract.

**Eye:** Will cause severe irritation and reddening. Prolonged contact may cause permanent damage.

**Skin:** Will cause irritation to the skin. Prolonged contact may cause chemical burns.

**Inhaled:** Inhalation will cause irritation and possible chemical burns to the mucous membrane and upper airways, especially if the material is heated or mists are generated.
